Please find enclosed an official ballot listing the names of the persons nominated to serve on the Board of Directors for the Rains County Appraisal District for the 2026-2027 terms and a copy of each entities voting entitlement.

In complying with the rules of the Property Tax Code, each voting unit must vote in an open meeting, report its vote by written resolution, and submit it to the Chief Appraiser by December 15, 2025. The unit may cast all its votes for one candidate or distribute the votes among any number of candidates.

A voting unit must cast its votes for a person nominated and listed on the ballot. There is no provision for a write in candidates. The Chief Appraiser may not count votes cast for someone not listed on the official ballot.

The candidates receiving the five highest cumulative numbers of votes will be elected. I will submit the results of the election to all taxing units by December 30, 2025.
