

WHEREAS, the Harris County Universal Services is directed by Harris County for the TxWARN Communication System; and


WHEREAS, Rains County in the State of Texas is joining the TxWARN radio system in conjunction with the radio tower build.


NOW, THEREFORE, BE IT RESOLVED BY RAINS COUNTY IN EMORY, TEXAS;






