

RESOLUTION AND ORDER OF THE COMMISSIONERS COURT OF RAINS COUNTY, TEXAS APPROVING PURCHASE OF STARLINK INTERNET SERVICES AND RELATED EQUIPMENT THROUGH SOURCEWELL COOPERATIVE PURCHASING

WHEREAS, the Commissioners Court of Rains County, Texas (“County”), is authorized under Texas law to acquire telecommunications and information technology services necessary for the conduct of county operations and the provision of governmental services; and

WHEREAS, reliable broadband internet connectivity is necessary to support county operations, public safety communications, emergency management functions, and other governmental services; and

WHEREAS, CDW Government LLC (“CDW”) has provided the County a quotation identified as Quote No. PTQN116, dated February 24, 2026, for the purchase of one (1) Starlink Standard Kit and a one-year Starlink Impact Plan service subscription, for a total purchase price of \$1,257.33; and

WHEREAS, the products and services described in the quotation are available through the Sourcewell Cooperative Purchasing Program (Contract No. 121923-CDWG), which Rains County is authorized to utilize pursuant to Texas Local Government Code Chapter 271, Subchapter F; and

WHEREAS, the Commissioners Court finds that procurement of such products and services through the Sourcewell Cooperative Purchasing Program satisfies applicable competitive procurement requirements and is in the best interest of the County; and

WHEREAS, the purchase and use of Starlink services require acceptance of Starlink’s Terms of Service and related service documentation referenced in the order process; and

WHEREAS, the Commissioners Court desires to approve the purchase and associated agreements subject to limitations required under Texas law governing county contracts.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF RAINS COUNTY, TEXAS, THAT:

1. **Approval of Purchase.** The Commissioners Court hereby approves the purchase of Starlink internet equipment and service subscription from CDW Government LLC pursuant to Quote No. PTQN116 dated February 24, 2026, through the Sourcewell Cooperative Purchasing Program (Contract No. 121923-CDWG), in the total amount of \$1,257.33.
2. **Authorization to Execute Documents.** The County Judge of Rains County is hereby authorized to execute, on behalf of the County, the purchase order, order confirmations, letter of authorization, and other ministerial documents necessary to complete the purchase and activate the Starlink services approved herein.

3. **Annual Appropriation Requirement.** Notwithstanding any provision of the Starlink Terms of Service or related documents, the obligations of Rains County under the service subscription are subject to the availability and appropriation of funds by the Commissioners Court in each fiscal year. If sufficient funds are not appropriated for any subsequent fiscal year of the service, the County may terminate the service without penalty.
4. **No Waiver of Governmental Immunity.** Nothing in the purchase documents, the Starlink Terms of Service, or this Resolution shall be construed as a waiver of the governmental or sovereign immunity of Rains County or of any rights, protections, or defenses available to the County under the Constitution and laws of the State of Texas.
5. **Compliance with Texas Law.** The agreements and services approved by this Resolution shall be construed and enforced in a manner consistent with the laws of the State of Texas, and any provision inconsistent with Texas law governing county contracts shall be interpreted so as to comply with such law.
6. **Effective Date.** This Resolution shall take effect immediately upon adoption.
