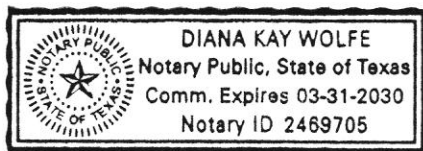

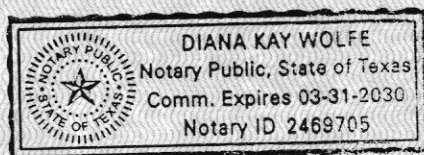

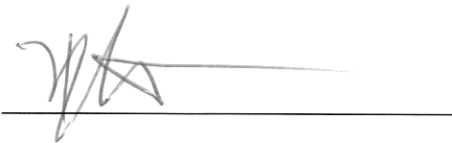
WHEREAS, the County Fire Marshal is required to take the oath prescribed by the Texas Constitution and post a bond in an amount specified by the Commissioners Court; and

4. This resolution shall take effect immediately upon adoption.

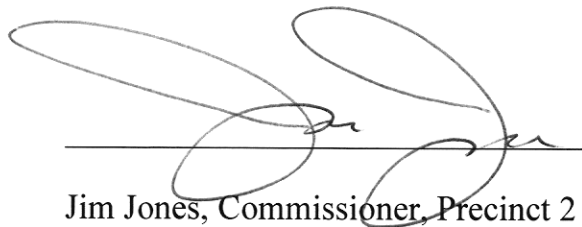

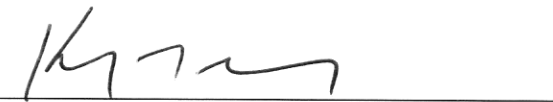

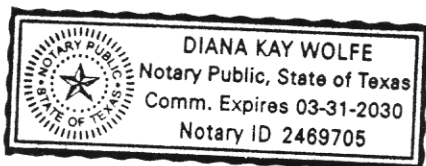
