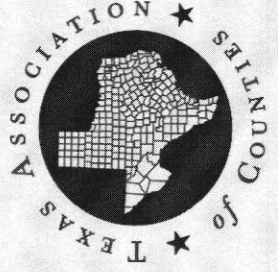

WHEREAS, completion of required training helps ensure transparency, accountability, and proper stewardship of public information and public resources; and

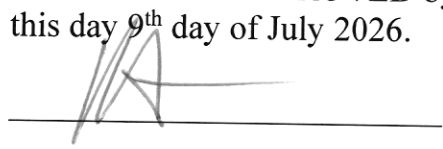

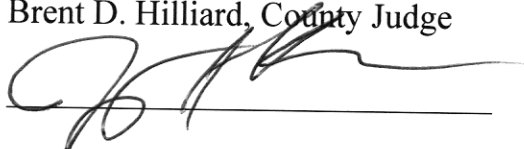
WHEREAS, the Commissioners' Court desires to accept and place said certificate into the official records of the County as a matter of record;

3. This resolution shall take effect immediately upon adoption.

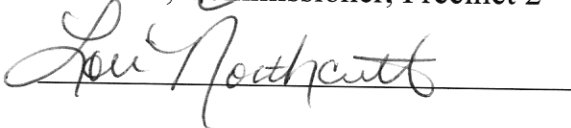
