WHEREAS, an Order of Election has been prepared calling for the November General Election for the purpose of electing the appropriate Rains County officers; and

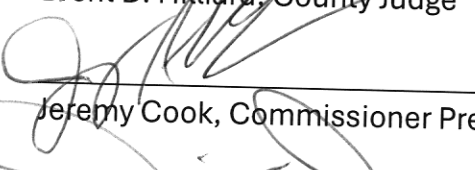
WHEREAS, the Commissioners' Court finds that approval of the Order of Election is necessary to ensure the timely and lawful administration of said election.

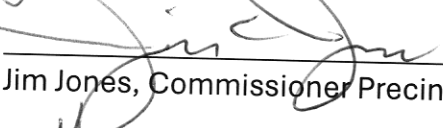
NOW, THEREFORE, BE IT RESOLVED that the Commissioners Court of Rains County, Texas:

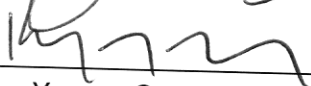
1. Approves the Order of Election for the November General Election for Rains County officers, as presented and attached hereto, if applicable.

3. Declares this resolution effective immediately upon its adoption.

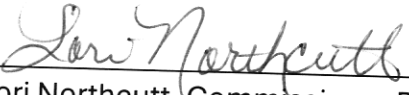

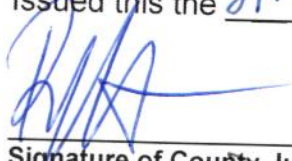

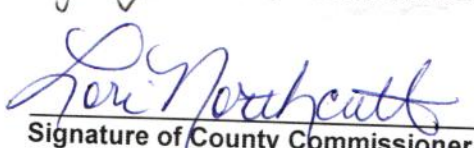
