PAYDAY CALENDAR FOR RAINS COUNTY, TEXAS**

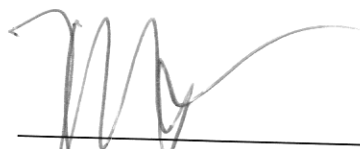
WHEREAS, the Rains County Commissioners Court finds it necessary to establish an official holiday and payday calendar for County employees; and

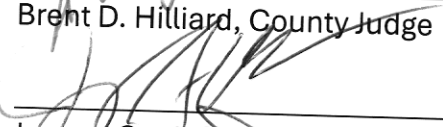
WHEREAS, adoption of the calendar promotes consistent administration of employee leave, payroll processing, and County operations;

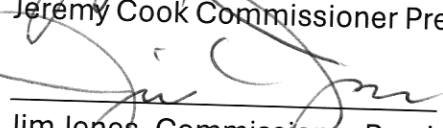
**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF
RAINS COUNTY, TEXAS, THAT:**

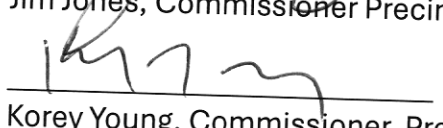
1. The Holiday and Payday Calendar presented to the Commissioners Court is hereby approved and adopted as the official calendar for Rains County for the applicable calendar year.

4. This Resolution shall take effect immediately upon its adoption.

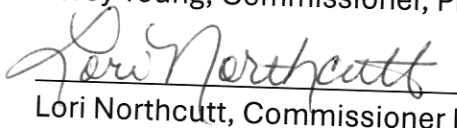
